<b>CANDIDATE ELIGIBILITY REQUIREMENTS</b>	<b>DEADLINE TO FILE CANDIDATE APPLICATION</b>	
Sec. 141.001. ELIGIBILITY REQUIREMENTS FOR PUBLIC OFFICE. (a) To be eligible to be a candidate for, or elected or appointed to, a public elective office in this state, a person must:  (1) be a United States citizen; (2) be 18 years of age or older on the first day of the term to be filled at the election or on the date of appointment, as applicable (3) have not been determined by a final judgment of a court exercising probate jurisdiction to be: (A) totally mentally incapacitated; or (B) partially mentally incapacitated without the right to vote; (4) have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities; (5) have resided continuously in the state for 12 months and in the territory from which the office is elected for six months immediately preceding the following date: (6) on the date described by Subdivision (5), be registered to vote in the territory from which the office is elected; and (7) satisfy any other eligibility requirements prescribed by law for the office.	Beginning Monday, January 19, 2022 Deadline Friday, February 18, 2022 at 5:00 p.m.
